On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after its name. Please put classes in numerical order and USE BLOCK CAPITALS throughout when completing this entry form. Any bank charges incurred through incorrectly completed or dishonoured cheques will be passed on to the owner concerned. The Kennel Club Ltd Authority to Compete (ATC Number) for dogs resident outside of the UK must be stated or the entry will be returned. **PLEASE CHECK ALL DETAILS BEFORE POSTING.**
