All dogs must be REGISTERED at The Kennel Club in the name of the owner. If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries. In case of dispute proof of postage of such applications may be required by The Kennel Club. Dogs under 18 months of age on the day of competition cannot be entered for competition. On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after it's name. Please put classes in numerical order and USE BLOCK CAPITALS throughout when completing this entry form. Not for competition entries will be accepted for dogs aged four calendar months and over. Any bank charges incurred through incorrectly completed or dishonoured cheques will be passed on to the owner concerned. The Kennel Club Authority to Compete (ATC Number) for dogs resident outside of the UK must be stated or the entry will be returned.
